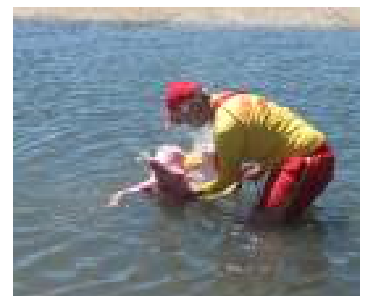
## MATERIALS AND SERVICES FEES
